<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The Water safety and Sanitation Certificate submitted is issued by the Senior manager (Health) of Greater NOIDA Industrial Development Authority, whereas it was required to be obtained from the Public Health Department. The School is required to submit the compliance of the same in 03 months on SARAS Portal.
2	The School has constructed CwSN toilets , however they do not have enough space to negotiate the movement of the Wheel Chair/Walker . Therefore, the school is required to construct the separate CwSN toilets for girls and boys on every floor with proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines, within 03 months and submit the compliance.
3	The School is required to make a separate reading space for staff in the Library and submit compliance within 03 months on the SARAS Portal.
4	The School is required to install the lift to access upper floors as per board's circular ( <a href="https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf">https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf</a> ) and submit compliance within 3 months on SARAS Portal.
5	The School is required to upload the copy of the recognition certificate, which is uploaded in the School's mandatory disclosure, in the compliance within 3 months on SARAS Portal.
6	The school shall conduct training of its teachers with CoE NOIDA within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be

initiated against the school as per Affiliation Bye -Laws-2018.

2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
